

Brexit - UKCA marking



According to the UK has left the EU,
the UKCA (UK Conformity Assessed)
marking is a new UK product marking
that will be used for goods being
placed on the market in Great Britain
(England, Wales and Scotland).



- The UKCA marking will not be recognized in the EU market. Products that require CE marking will still need a CE marking to be sold in the EU.
- The UK Government has confirmed that the UKCA mark will come into force on 1 Jan 2021, although CE marking will continue to be recognized in the UK until the end of 2021, as long as the UK and EU regulations remain aligned (exclude some products). However, from the beginning of 2022 only products with UKCA marking will be accepted in Great Britain.

Brexit - UKCA marking

Most products that are currently covered under regulations and directives for CE marking will fall under the scope of UKCA marking.

Product areas covered by the UKCA marking

- Toy safety
- Simple pressure vessels
- Electromagnetic compatibility
- Lifts
- ATEX
- Radio equipment
- Pressure equipment
- Personal protective equipment
- Machinery
- Low voltage electrical equipment, etc.
