
# Information on the auditor training Course for the second half of 2022

- This is related to the Technical Standards Department -867 (6.26.3, 2022.6.3, notice of administrative notice (collection of opinions) of partial revision (draft) of technical standards for wireless equipment for telecommunication business).
- In accordance with the partial revision of the technical standards for wireless facilities for the telecommunication business reflecting the additional allocation of 3.5 GHz band
  5G mobile communication frequencies, the guidelines for handling conformity assessment are as follows for a smooth conformity assessment.
